5. That the pay scale of the teaching staff and technical staff of Vidyalaya will not be less than the staff of Government aided institutions, but no other allowances will be given to them.
6. That a Service rules and regulations will be made by the management and management will provide/ pay the benefits to its employees at the time of retirement as provided by the Government Aided Higher Secondary Education Vidyalaya to its employees.
7. That Institution / Vidyalaya shall follow the rule and order issued by the State Govt. time to time.
8. That the record of the Vidhalaya, shall be kept in prescribed registries/Panjika.

That the said Supplementary Deed has no effect on stamp duty.

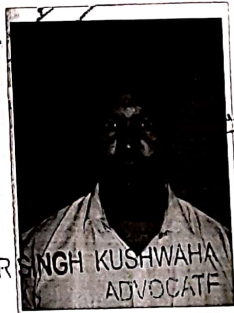




